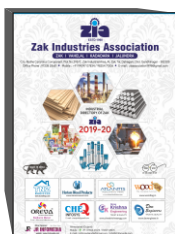

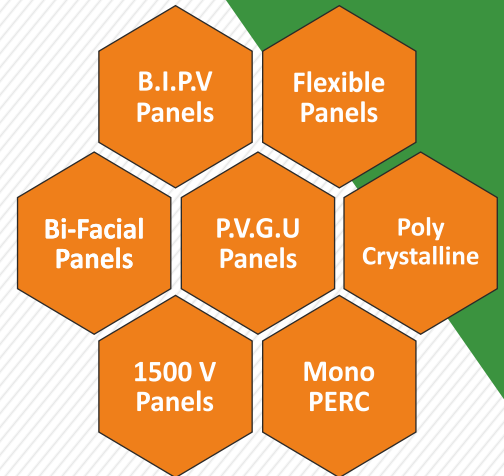

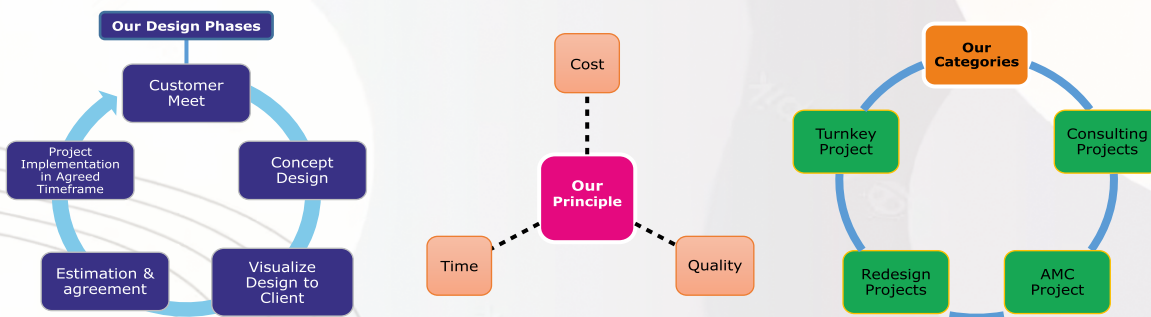

## Industrial Companies Must Transform How They Capture

Industrial companies must transform how they capture, manage and analyze water data at every stage of their operations. Automation, analytics and remote monitoring are critical components of a meaningful water sustainability program.

No matter what industry you find yourself in, water sustainability, conservation and resiliency are essential areas that companies emphasize. While the United States used to be a water-rich country and, in many ways, still is, with recent droughts across the Midwest and changing climate patterns, many areas are seeing what used to be an abundant resource become scarce. Water patterns are shifting. Glacial reserves are dwindling, and water runoff that traditionally fed dams and aquifers is unreliable and unpredictable. With many operations relying on local resources or utilities to meet their water needs, companies are also bumping up against the needs of local communities that require clean, reliable resources to exist against the organization's needs. Water uncertainty is quickly becoming a more prevalent problem. Many companies, for that reason, are looking for ways to address their usage and become more thoughtful consumers of this precious resource. Ultimately, internal water policies that, even a few years ago, might have once been considered just "good PR" are quickly becoming an operational necessity.

### Water and Industry

While water covers 71% of the earth, most is saltwater, with just 3% of its water being fresh. Both humans and industries rely on freshwater to survive and thrive, but not all freshwater is readily available. Most, for example, is trapped in the form of ice at the poles and in glaciers; as a result, only 1% of freshwater is readily available for use across various applications.

The world withdraws 4.3 trillion cubic meters of water every year, and agricultural operations use 70%. The United States uses approximately 37% for industrial applications and 40% for agriculture.

The world over, industries rely heavily on water and have a significant water footprint across four distinct areas:

- **Raw materials**
- **Suppliers**
- **Direct operations**
- **Product use**

Industrial practices rely heavily on large amounts of water to produce and deliver products. With water reserves dwindling or becoming ever more insecure, there are instances in which industry needs and surrounding community needs conflict — and it makes good business sense to reduce usage and contamination of water supplies. It is also the right for the environment and local populations.

### Water pollution is a real problem

Worldwide, 80% of water returns to the environment without being sufficiently treated. While this number is higher in low-income countries (92%), even in high-income earning states (like the U.S.), an average of 30% of water is insufficiently treated before being released.

Agricultural runoff is one of the leading causes of water pollution. Freshwater can become infected with algal blooms caused by high levels of nitrogen and phosphorus that can deplete the water of oxygen, making it undrinkable and leading to the die-off of many organisms. However, agricultural practices are not the only culprit. Industries such as oil and gas use large amounts of water in extraction processes. When wells fail, leaks in wastewater transport occur, or when wastewater storage is poorly designed - contaminated water can re-enter the environment. In 2018, North Dakota alone reported 400 wastewater spills. Other industries, from mining to meat processing and packaging, also have reputations for using large amounts of water during their processes and/or returning inappropriately treated wastewater into the environment. For example, in 2019, slaughterhouses in the U.S. were responsible for releasing more than 28 million

pounds of phosphorus and nitrogen into various waterways. American mines are estimated to allow more than 50 million gallons of contaminated wastewater to enter waterways daily. Even technology uses unsustainable amounts of water via water-cooled data centers using approximately 3.5 million gallons of water per MW each year. Large quantities of water are needed, and to keep server racks cool requires just as much wastewater. The inefficient processes threaten to suck up much of the available fresh water in drought-prone states like California.

### **Companies understand the urgency of water sustainability**

In 2020, more than 509 investors (with an estimated \$110 trillion in assets) requested that companies disclose water security risks, impacts and actions through the CDP (formerly Carbon Disclosure Project) platform. The CDP is a worldwide disclosure system for companies, investors and cities/states/regions. These requests demonstrate investors' concerns about how water affects a company's long-term gains. A recent CDP report highlights the stakes for businesses writ large: the cost of inaction on water risks is five times the cost of action. Companies that refuse to rethink their business models or transform their approaches to adopt more water-secure technologies and practices stand to take a substantial hit to their bottom line in the years to come — and investors are beginning to notice.

Therefore, implementing water sustainability best practices is happening with a new sense of urgency. Many organizations across industrial and food processing sectors are pledging to seek ways to lower their water footprint over the next decade in the same way they have attempted to reduce their carbon footprint the decade before. The difference, however, is a sense that if inaction drags on for too long, the long- and short-term consequences could spell monetary and production disaster for any number of organizations.

Environmental, social and governance (ESG) mandates are nothing new, especially for multi-nationals and large-scale enterprises. However, water sustainability ties directly to the productivity of a business, which may be why many companies are working to lower their water footprint in a far shorter timeframe. As a result, many household brands are improving their processes to ensure they use less water or even return more water into the environment than is needed for day-to-day operations.

Net-positive water pledges are fast becoming a standard way companies promise water sustainability. As a result, many companies have pledged to substantially reduce water usage across operations or be net-positive (with many guaranteeing net-positivity by 2030).

### **Many companies in Sanand with net-positive**

as more companies realize the impact - and cost - high water usage can have on their businesses and, as reserves continue to dwindle, expect even more to adopt aggressive water-saving measures across their operations.

The challenges of water quality and conservation for business

There is a general concern that it makes sense, cost-wise, to bake in water sustainability best practices.

Many companies are just starting their water conservation journey by simply tracking their usage. However, to become more water resilient, they will have to ensure the data they are capturing is correct and informative enough to provide insights into what next steps are necessary on the road to water sustainability. While, on average, more companies are starting to track their water withdrawals, discharge and consumption, most organizations are not leveraging remote water monitoring technologies. As a result, many companies are not operating as efficiently as they could to meet ambitious sustainability goals.

By coupling remote monitoring with artificial intelligence (AI) and machine learning, companies will be able to identify trends and build models related to water quality and usage. As a result, they will be better able to calibrate processes, understand water data from various angles and make proactive decisions that conserve water, increase efficiency, improve water quality and reduce operational costs.

## Amendment in Section 43 B

### Allowance of Expenses on Payment basis to Micro or Small Enterprises

#### **Introduction :**

The Union Budget 2023 provided way forward for steering the economy towards as sustainable and high growth. One of the steps is to make sure that the payment to be made to MSME timely basis i.e as per MSME Act, 1961. This will result in smooth working capital management by Micro and Small enterprises, which are backbone to Indian economy. It is proposed to include payments made to such enterprises within the ambit of section 43B of the Income Tax Act, 1961. So the deduction for such payments would be Thus a deduction for such payment would be allowed only when they are actually paid. This will be allowed on an accrual basis only if the payment is within the time mandated under section 15 of the MSMED Act, 2006.

At present, payments to Micro, Small and Medium Enterprises (MSMEs') registered under Micro, small and Medium Enterprises Development Act, 2006 are disallowing the interest paid in case of delayed payment to MSMEs while computing Taxable income under Section 23 of MSME Act, 2006.

Section 43B of the Income Tax allows deduction in respect of certain expense only when the such sum is actually paid by the Assessee. It further states that the same can be allowed even though such amount has been actually paid before filing Income Tax Return.

The proviso has also been amended to exclude proposed clause 'h' from allowance in case payment made to MSME on or before the due date of filing of Income Tax Return under section 139 of the Act.

Section 15 of MSMED Act, states that the buyer must pay to MSE vendor within 15 days of delivery of goods or provision of services in absence of a written agreement.

If there is a written agreement in relation to payment terms between parties, the payment terms cannot be stipulated in excess of 45 days. Therefore, even if the parties agree to payment terms of more than 45 days, the law mandates to pay within 45 days.

It is relevant to note that Section 43B is attracted only when the payment is made to “Micro” and “Small” Enterprise registered under MSME Act, 2006 and does not include “Medium” enterprise registered under MSME Act 2006.

The table below shows the difference in the different Enterprises based on Investments and Turnover under MSME Act, 2006...

There are other provisions related to MSME which also need to understand while dealing with MSME.

1. GST provision mandates payment within 180 days in case Input Tax credit.
2. Disclosure as per Companies Act of outstanding balance and interest there on due to MSE in Financial Statement
3. Interest disallowance under Income Tax Act in case of delay in Payment

In our opinion the proposed amendment may lead to following four situations for payment to micro and small enterprises:

1. Accrual of Expenses and Payment within Time Limit as prescribed under section 15 of MSME Act, 2006 and in the same Financial year: No Disallowance under section 43B
2. Payment made beyond the time limit mentioned under section 15 of the MSME Act, 2006 but within the financial year in which expenses incurred: Section 43 will be triggered. However payment made in Same financial year in which expenses accrued and so deduction can be allowed in the said financial year as per section 37 read with Section 43B.
3. Accrual of expenses in the FY and paid in subsequent FY but within the time limit prescribed under section 15 of MSME Act, 2006 : Expenses would be allowed in the year of accrual.
4. Accrual of Expenses in the FY and paid in the Subsequent FY but not within the time limit prescribed under section 15 of the MSME Act, 2006.: Expenses will be disallowed as it is not paid within time limit as well as not in the same year in which expenses accrued. It will be allowed in the subsequent year.

**Conclusion:**

Although the proposed amendment in section 43 B by Finance Bill, 2023 would ensure the timely payment to MSMEs and that help in their working capital management, it will affect where the mutually agreed period is more than 45 days ie contractual payments. It also necessitates companies to follow a certain mechanism to track the payments in 45 days and prepare detailed statement for auditors to check the payments paid beyond due dates but within the FY and Payment paid within due dates but paid in subsequent year and may lead to higher operational cost in Large and medium companies to adhere this provisions.

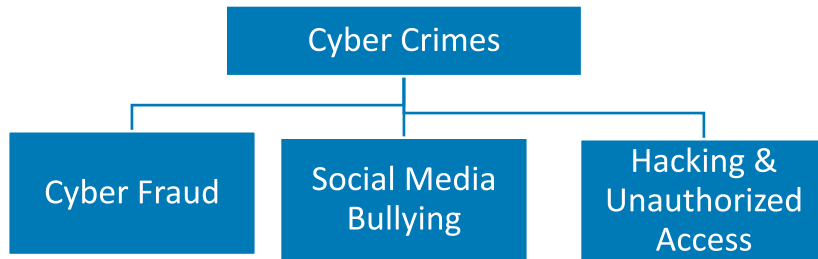

### Bank Impersonation

- Callers say they are calling from bank and take away details.
- Now many people know that the OTP shouldn't be shared, so now the fraudsters make the victims install any remote access application like 'any desk', 'team viewer' etc.
- Now the control of the phone goes in the hands of the fraudster and he doesn't need the victim to share any details.
- Jharkhand is a hub for such crimes.

### Google Search Fraud

- The victims often search for helpline numbers of banks, companies, institutions etc.
- The fraudsters take advantage of this and place Google Advertisements which appear before the search results
- The victims thinking that they have called the real helpline number, give away their banking details and get cheated
- This type of fraud is the most used method of Cyber Fraud

### KYC Updation Fraud

- The victims are told that their bank account/ Paytm/ Debit Card is going to be closed because of non-compliance of KYC
- In order to complete the KYC they have to give the banking details and an OTP for updation of the KYC

### Loan Application Fraud

- Hundreds of application provide small loans
- Permissions taken during installation: contact details
- Victims' contact persons are harassing claiming a huge loan taken by victim
- Suicides have also reported in some cases
- Chinese gangs involved initially in these apps

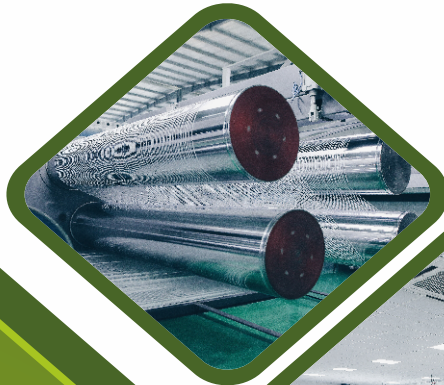

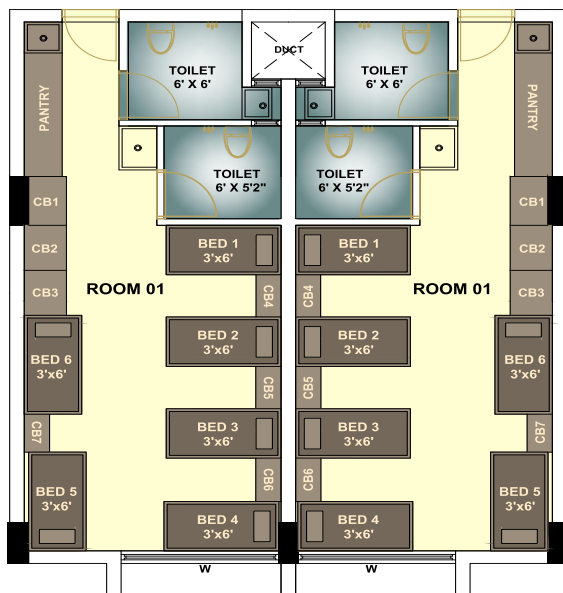

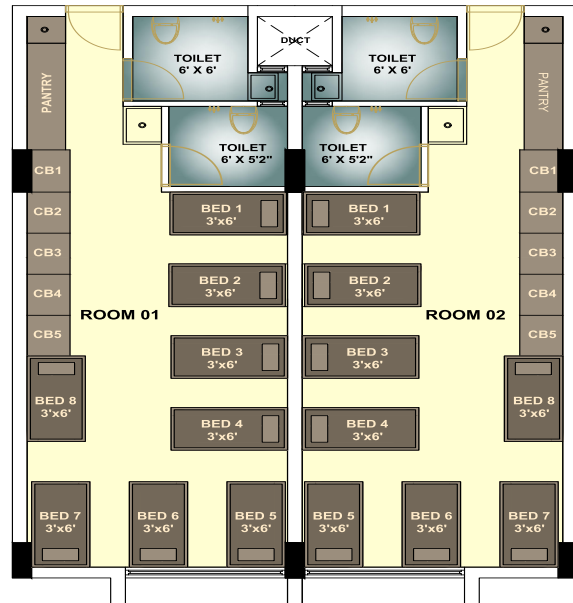
